TROPICAL CYCLONE "VAYU" IN THE ARABIAN SEA.

Pakistan Meteorological Department has issued cyclone alert dated: 11.06.2019 Time 1100 PST relating to Tropical Cyclone Formation in Arabian Sea, reproduced as under:

"Yesterday's deep depression in the East Arabian Sea having moved North/Northwest-ward intensified into a Tropical Cyclone "VAYU" and lay centred around Lat.14.7N and Long.70.6E at 0800PST of 11 June 2019. The Tropical Cyclone "VAYU" currently locates at a distance of about 1150 km south of Karachi. The maximum sustained surface winds are 70-80km/hour gusting to 90 km/hour around the system centre.

The system is likely to intensify further into a Severe Tropical Cyclone by evening today and will continue to move in northerly direction during next 24 hours.

Under the influence of this system, widespread Dust/Thunder-showers with isolated heavy falls are expected in southeast Sindh (Thatta, Sajawal Badin and Tharparker districts) on Thursday/Friday. While scattered/isolated Dust-thundershowers may occur in rest of Sindh during the period.

The sea breeze is likely to remain cut off on Thursday/Friday which can lead to heat wave like conditions in coastal areas of Sindh including Karachi.

The fishermen of Sindh are advised not to venture in open sea during Wednesday evening to Friday evening, as the sea conditions are likely to be rough/very rough.

Note: All concerned authorities of Sindh province are requested to remain alert during coming days regarding the impact of TC VAYU".

2. The following authorities are requested to remain alert and take all necessary actions as mentioned below:

1. **DDMAs:** Keeping in view the expected widespread Dust/Thunder-showers with isolated heavy falls necessary preparations should be made. It is advised to make necessary arrangements for evacuation of people, if needed, from low lying areas of coastal belt. It is also advised that shelters and evacuation routes may be identified, in case of any emergency. Furthermore the sea breeze is likely to remain cut off on Thursday / Friday which can lead to heat wave like conditions in coastal areas of Sindh including Karachi. It is also requested to kindly ensure all precautionary measures to avoid any untoward situation.

(i) **Home Department:** Advised to impose and ensure compliance of section 144 in the entire coastal area of Sindh.

Local Government Department: To ensure preparedness and to ensure response measures are in place along with removal of loose structures, tall mounted billboards and hoardings which may fall due to high winds. The staff is to be kept on high alert. Storm water drains should be kept clean.

- (iii) **K-Electric/HESCO:** Ensure uninterrupted power supply to pumping stations for drainage of rain water. Secure electric transmission lines in case of high winds that may cause their falls. Ensure prompt action to avoid electrocution due to fallen electric wires.
- (iv) **DHA/ Cantonments Board (Coastal Area):** Ensure removal of loose structures, billboards, hoardings, and drainage of rain water.
- (v) **Livestock & Fisheries Deptt. / JMICC:** To ensure safe return of fishermen already in sea and no further venture in open sea till Friday evening.
- (vi) **MCs & UCs:** To ensure that all the drainage/nallahs have been cleaned to facilitate smooth and quick drainage of water.

3. In view of above, I am directed to request that the District Administration may remain alert / cautious and all stakeholders should be cautioned to take necessary precautionary measures to avoid any loss of life and damage to public as well as private property. For further coordination and updates PDMA may be contacted.

4. This issues with the approval of Director General, Provincial Disaster Management Authority, Sindh.
