1. The Provincial Government of Sindh has received a Credit from the World Bank under the Sindh Resilience Project – PDMA Component. It is intended that part of the proceeds of this Credit will be applied to eligible payments under the contract for strengthening the capacity of PDMA Sindh for disaster risk management.

2. The **Sindh Resilience Project (PDMA Sindh Component)** now invites sealed bids from eligible bidders for the Procurement of IT related goods and services for **Development of DMIS & Establishment of Provincial Emergency Operation Center at PDMA Sindh (HQ)**

3. Bidders may bid for one or more lots, as further defined in the bidding document. Evaluation and award shall be on basis of individual lots wise. All bidders shall be required to submit with their bid, information on their eligibility and qualification as per the Bid Data Sheet included in the bidding document. Interested eligible bidders may obtain further information from and inspect the bidding documents at the address give below from **0900 to 1700 hours on any working day** before closing date i.e; **05 March 2020 at 1230hrs**

4. A complete set of bidding documents may be purchased by interested bidders on the submission of a written application to the above and upon payment of a nonrefundable fee of Rs. 2,000/- cash or bank draft.

5. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Documents: Procurement of Goods for National Competitive Bidding, Pakistan*, Part One. Procurement shall be done through National Competitive Bidding (NCB) method in accordance with paragraph 3.3 of Guidelines Procurement of Goods, Works, and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011 revised (July 2014).

6. A **pre-bid meeting** will be conducted on **February 12, 2020 at 1200hrs** in the address given below. All potential bidders are invited and encouraged to attend the pre-bid meeting.

7. Bids shall be valid for a period of **90 days** after Bid opening and must be accompanied by security of **2%** of the Bid Price and in the form of a Bank Guarantee in favor of Project Director Sindh Resilience Project (PDMA Component) and shall be delivered to **Project Director, Sindh Resilience Project (PDMA Component) Plot 26-C, DHA, Khayaban-e-Jami, Phase 7, Karachi** on or before **March 05, 2020 at 1230 hrs PST**. The submitted bids will be opened on the **same day at 1230 hrs PST** in the presence of Authorized Representative of the firms who wish to attend.

8. The bidders are requested to give their best and final prices as no negotiations are expected.
