SUBJECT: - WEATHER WARNING NO. 1 FOR SINDH PROVINCE DURING NEXT THREE DAYS

The Pakistan Meteorological Department (PMD) has conveyed Weather Warning for Sindh dated: **22nd July 2017**, reproduced as under:

“A strong monsoon weather system is effecting southern parts of the province. Under its influence Rain/thundershowers with isolated heavy to very heavy falls and strong gusty winds may occur at a number of places in district Thatta and Mirpurkhas, Hyderabad divisions and at scattered places in Karachi, Sukkur, Larkana and Sh. Benazirabad divisions during next 3 days. Sea condition may remain rough to very rough. Fishermen are therefore advised to take precautionary measures and not to venture in deep sea during the period.”

2. In view of above, I am directed to request that the District Administration may remain alert / cautious and all stakeholders and concerned should be cautioned to take necessary precautionary measures to avoid any loss of life and damage to public as well as private property.
