FLOOD WARNING

Subject: RIVER SITUATION AND QUALITATIVE FLOOD/ WEATHER FORECAST.
Pakistan Meteorological Department (PMD) vide its Bulletin No. A-064/22 dated: 17.08.2022, has informed that River Indus is at Low Flood level at Guddu and Sukkur. **SEVERE Flash Flooding is expected in the Hill Torrents of D.G. Khan Division along with Rivers/ Nullahs of Eastern Balochistan during 17th to 19th August, 2022.** Flows from Hill Torrents of D.G. Khan Division may cause **Medium to High Level Flooding in River Indus at Guddu & Sukkur. SEVERE Urban Flooding is also expected in Sindh during 17th to 19th August, 2022.**

For next 24 hours:

WIDESPREAD THUNDER STORM/RAIN with HEAVY TO VERY HEAVY FALLS at scattered places and **EXTREMELY HEAVY FALLS** at isolated places is expected over **SINDH.**

Weather outlook for 18th to 19th August, 2022:

FAIRLY WIDESPREAD THUNDER STORM/RAIN with VERY HEAVY FALLS at scattered places and **EXTREMELY HEAVY FALLS** at isolated places is expected over **SINDH.**

Possible Impacts

- Heavy falls may create water-logging/urban flooding in low lying areas Sindh.
- Persistent heavy rains over Khuzdar, Lasbella and Hub distts of Balochistan & over Kirthar Range may create extra pressure on Hub dam, Thaddo dam & downstream nullahs.
- Sea conditions likely to remain rough & fishermen are advised not to venture in deep sea.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding/urban flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.

- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Move to safe places in case of any risk of Flash Flooding/Urban Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
