
Subject: QUALITATIVE WEATHER / FLOOD FORECAST.

I am directed to refer to the subject noted above and to enclose herewith a copy of the Pakistan Meteorological Department—*BULLETIN No. B-057/19*, dated, 10th August, 2019, whereby identifying inflow and outflow of flood water at Guddu, Sukkur & Kotri Barrages. The salient extract of the same is reproduced as under
