WEATHER OUTLOOK

Subject **DUST-THUNDERSTORM/RAIN WITH ISOLATED MODERATE/HEAVY FALLS
ARE LIKELY TO OCCUR AT A FEW PLACES IN SINDH**

Pakistan Meteorological Department (PMD) has informed vide its Weather Outlook dated 12th September, 2022, that a low-pressure area over Indian Gujarat persists and the Depression over east India now lies over central India.

Under the influence of these Weather System:

- Dust-thunderstorm/rain with isolated moderate/ heavy falls is likely to occur at a few places in **Tharparker, Umerkot, Badin, Sanghar, Khairpur and Mirpurkhas**, districts from today to 15th September with occasional gaps, while in **Hyderabad, Tando Allayar, Matiari, Jamshoro, Tando Muhammad Khan, Sujawal and Thatta** districts from **today to 14th September**.
- **Karachi** to experience **hot and humid weather** with chances of **moderate to heavy dust-thunderstorm/rain at a few places today and tomorrow afternoon**.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen District Disaster Management Authority and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Identify sites and establish relief camps for evacuated population, owing to the threat of flooding.
- Provide necessary arrangements for the provision of cooked food at the Relief Camps.
- Take necessary precautions to curtail the outbreak of water-borne diseases by ensuring provision of clean water to the evacuated population.
- Mobilize health teams to provide medical attention to the sick and injured among the affected population.
- Coordinate with concerned departments to avoid blockage/ closure of roads due to rain and flooding.
- Take necessary steps in collaboration with respective power providers to prevent incidents of electrocution during rain.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.

- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Establish Heat Stroke Centers at Private Hospitals, Basic / Rural Health Units (B/RHUs) or at any available government buildings and community centers having backup generators facility in case of power failure and assure provision / availability of water at such Centers in the districts experiencing elevated temperatures.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Avoid venturing outside unnecessarily in the afternoon in the areas with forecast of elevated temperatures.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
