WEATHER ADVISORY

Subject **MORE MONSOON RAINS PREDICTED IN COMING DAYS**

Pakistan Meteorological Department (PMD) has issued a press release dated 19th July, 2022, that, rain-wind/thundershowers (with few heavy falls) are expected in all the districts of Sindh from **24th to 26th July, 2022.**

POSSIBLE IMPACTS:

- Heavy falls may generate urban flooding/water logging in **Karachi division, Hyderabad, Thatta, Badin, Shaheed Benazirabad, Jamshoro, Mirpurkhas, Dadu, Umer Kot, Jaccobabad, Larkana and Sukkur** of the province.
- Travelers and tourists are advised to remain more cautious during the **forecast period.**
- Farmers are advised to arrange the watering of the fields accordingly.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Coordinate with all authorities to ensure smooth flow of storm water drains in Urban areas.
- Ensure early warning mechanism for evacuation of vulnerable population in areas/ districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and

ensure preventive measures against fires due to electrification, where possible.

- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
