I am directed to refer to Pakistan Meteorological Department Flood Forecasting Division Bulletin No. A-87/20 & B-87/20 dated 09<sup>th</sup> September, 2020, under which flowing has been forecasted:

**HYDROLOGICAL SITUATION:**

River Indus at **Guddu** is in **HIGH Flood level**, at **Sukkur** in Medium Flood Level and at Taunsa is in Low Flood Level. All the other Major Rivers are flowing below Low Flood Level

**METEOROLOGICAL FEATURES:**

Weak Seasonal Low lies over Northeast Balochistan.
