WEATHER WARNING

Subject: STRONG MONSOON CURRENTS LIKELY TO PENETRATE INTO SINDH FROM 22 JULY (FRIDAY) NIGHT / 23 JULY (SATURDAY) MORNING TILL 26 JULY (TUESDAY)

Pakistan Meteorological Department (PMD) has informed vide its Press Release dated 21th July, 2022, the strong monsoon currents are likely to penetrate into Sindh from **22 July (Friday) night / 23 July (Saturday) morning & will prevail till 26 July (Tuesday)**.

Under the influence of this weather system:

Widespread **rain-wind/thunderstorms** with **scattered heavy/very heavy falls** are likely in **Tharparker, Umerkot, Mirpurkhas, Badin, Thatta, Tando M Khan, Tando Allayar, Hyderabad, Matiari, Sanghar, Nawabshah, Khairpur, Sukkur, Larkana, Jacobabad, Dadu, Jamshoro, Shikarpur, Qambar Shahdadkot, Ghotki and Kashmore** districts, during **23rd - 26th July, 2022** and in **Karachi Division** during **24th - 26th July, 2022**.

Possible Impacts

- Heavy/very heavy rainfall may generate urban flooding/ water logging in low lying areas of **Karachi division, Matiari, Hyderabad, Thatta, Badin, Mirpurkhas, Umerkot, Tharparker, Tando Muhammad Khan, Tando Allahyar, Sanghar, Nawabshah, Dadu, Jamshoro, Qambar Shahdadkot, Larkana and Sukkur** during the forecast period.
- Strong winds may damage vulnerable & loose structures.
- Persistent heavy spell over Khuzdar, Lasbella, Hub & along Kirthar Range may create pressure on Hub Dam & Flash Flooding in **Dadu & Jamshoro** districts & downstream.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.
- Emergency services and ambulances with trained paramedics to remain available round the clock.

- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
