MONSOON WEATHER ALERT

Subject: THE LOW PRESSURE AREA OVER WEST RAJASTHAN, INDIA NOW LIES OVER NORTHWEST RAJASTHAN & ADJOINING NORTHEAST SINDH.

Pakistan Meteorological Department (PMD) has informed vide its Monsoon Weather Alert, dated 27th July, 2022, that, the Low-pressure area causing widespread heavy rains in Sindh has moved westward, towards Oman coast. The low pressure area over west Rajasthan, India now lies over northwest Rajasthan & adjoining northeast Sindh.

Under the influence of this weather system:

Rain/thunderstorms with isolated heavy falls likely to continue in Nawabshah, Khairpur, Sukkur, Larkana, Jacobabad, Dadu, Jamshoro, Shikarpur, Kambar Shahdadkot, Ghotki & Kashmore districts during next 2/3 days, while light/ moderate rain is expected in Badin, Thatta, Sujawal, Hyderabad, T. M. Khan, Tando Allayar, Mirpurkhas and Karachi division today.

Possible Impacts

- Heavy falls may generate urban flooding/water-logging in low lying areas of Sindh during the forecast period.
- Persistent heavy spell over Khuzdar, Lasbella, Hub & along Kirthar Range may create pressure on **Hub Dam and Flash Flooding** in **Dadu, Kamber Shahdadkot and Jamshoro** districts and downstream.

Keeping in view above, it is recommended that concerned Deputy Commissioners/ Chairmen DDMA's and other relevant authorities/ stakeholders may take all necessary mitigation measures including:

- Ensure early warning mechanism for evacuation of vulnerable population in areas/districts in case of flash flooding.
- Ensure availability of dewatering machines and the staff during rainfall.
- Improve coordination with emergency services, also with various line departments.
- Establishment of helpline Cell number to address needs of affected people at priority basis.
- Ensure provision of water and necessary emergency medicines to the general public during emergency.
- Stockpile necessary emergency relief/ medicine stores especially in affected areas.
- Keep the machinery on standby for plugging in breeches to LBOD/drainage network/ canals.
- Ensure availability of uninterrupted power supply through intimate coordination with concerned line departments and provision / availability of standby generators for hospitals.

- Emergency services and ambulances with trained paramedics to remain available round the clock.
- Emergency Services / Fire Brigades to remain alert for possible fire incidents and ensure preventive measures against fires due to electrification, where possible.
- Coordinate with concerned departments (NHA, NH&MP and FWO) for issuing necessary alerts to travelers, especially over long distances to take precaution and avoid over exposure to rainfall.

FOR GENERAL PUBLIC

- Move to safe places in case of any risk of Flash Flooding.
- Monitor the weather updates and flash flood alerts regularly through print and electronic media.
- Keep emergency medicines/kits and emergency food rations with themselves.
- Wear protective clothing and seek indoor shelter.
- Stay away from windows and doors during heavy rain and strong winds.
- Avoid roadway underpasses, drainage ditches, low-lying areas and areas where water collects there can be unexpectedly flood or overflow.
- Avoid driving in heavy rain due to poor visibility.
- Travelers and tourists are advised to remain extra cautious during the forecast period.
